### **Background**

Bytown Brigantine, a well-established and unique tall ship sail training organization, operates a variety of year-round programs for youth and adults. Founded in 1984, the Foundation is dedicated to providing adventure and character-building experiences. Tall ship sail training programs are carried out aboard the brigantines Fair Jeanne and Black Jack in the St. Lawrence Seaway/Great Lakes. Winter work parties and leadership programs are conducted ashore at our headquarters in Ottawa.

### **Position Summary**

We are currently inviting applications for the position of Master, Black Jack (May/June to September/October). The position is live-aboard during camp sessions that are either 5 or 10-days. Black Jack operates in the 1000 Islands on the St Lawrence River with youth 12-14 years of age from the port of Brockville, Ontario. This position appeals to the person who enjoys working with youth and remembers how they learned to enjoy life on the water.

#### **General Responsibilities**

- Working through the board of directors, reporting directly to the President of the foundation the Master is responsible for the operation and safety of the vessel, her crew, trainees and gear, in compliance with applicable laws and regulations, Bytown Brigantine Standing Orders and governing authorities, and
- Instructs, demonstrates and leads by example Bytown's sail training curriculum, for the benefit
  of trainees, to carry out the objectives of the foundation aboard ship, while fostering and
  promoting an environment conducive to achieving a rewarding and character building
  experience for the trainees. Leads and carries out such other duties aboard ship, or on land,
  consistent with the required elements of operating a non-profit, charitable, sail training
  program, and
- Cooperates with and encourages volunteer participation in program activities, operations, shipyards, etc., and
- Maintains such records, logs, or produces such reports and ship's standing orders, as may be required for the smooth, efficient and compliant operation of the program, and
- Acts as host/ambassador for the foundation/program when carrying out the above.

- Police Records Check for work with the vulnerable sector.
- Must be eligible to work in Canada
- Excellent communication skills and experience working with youth
